**PROJECT DESCRIPTION:** Rehabilitation a deteriorated portion of the City of Sparks' Regional Trail, originally constructed with pavers. Scope of the project includes removing the paver trail and reconstructing the trail with portland cement concrete (PCC). Project also involves a retaining wall, handrail, and riprap placement.
