This addendum is to notify all potential proposers of clarifications made to the Bid documents as stated below.

RFI Questions and Answers:

- 1) **Are there any specifications available for the new light poles and led fixture heads?**

Answer: See Detail 3/E2.2 for pole information. Fixture shall be Cree XSP2:bxsp Series C Type 3 Distribution 139W 40k SV w/ photocell and bird spikes or equal.

- 2) **Are there any specifications for the lightning rods shown on the pole tops?**

Answer: Air terminal shall be 5/8" 24" long pointed bare copper.

- 3) **Are there any specifications for the fiber optic cabling**

Answer: Yes. See Addendum 1.

- 4) **The drawings do not show any in-ground pull boxes between the facility and the new front gate. Are we supposed to add those in? How many will be required?**

Answer: See Addendum 1 for additional boxes to boxes already shown on site plans.

- 5) **Can you define the scope of work for the security, intercom and access controls? The plans are very unclear as to what will be required and what systems are already installed and just need to be added on to. Please clarify.**

Answer: Contractor is responsible for providing all access control components and connections to Owner's network. Owner will integrate into existing access control system software.

Contractor is responsible for providing all access control components, connection, and programming into Owner's existing Software House access control system. Network switches will be provided by Owner.

- 6) **What is meant by 120VAC Power Supply (Should this be TVSS? Or provisions for incoming 120V**

Answer: Provisions for incoming power only.

- 7) **Accessories for 2 racks – How many rack units and does this refer to two separate 19” racks?**

Answer: The intent is to provide mounting accessories and a full height 19” rack to accommodate Owner supplied networking equipment and UPS.

- 8) **Are there other networking or panel accessories required that are not identified on the sheet note**

Answer: No.

- 9) **E1.2 note 6 is asking for a floor mounted network cabinet with a UPS. Please give part number for UPS and Floor mounted cabinet.**

Answer: UPS will be Owner furnished. See note 6, E1.2 for cabinet specification.

- 10) **Is the Access Control System for this project an extension off an existing enterprise/corporate system in which there is an existing remote data base server that proposed system needs to connect too?**

Answer: Yes this project an extension off an existing enterprise/corporate system. The successful contractor is responsible for providing cabling and raceway per drawings for connecting into existing system. The owner will provide all modifications and programming to integrate new gate into database.

- 11) **What Access Control System is being used?**

Answer: Software House is the Access Control System.

- 12) **Will additional licensing be required for the Access System? If so, who will be providing them?**

Answer: No additional licensing required.

- 13) **Is the Camera Surveillance System/Video Management System for this project an extension off an existing enterprise/corporate system in which there is an existing remote management server that proposed system needs to connect too?**

Answer: Yes this project an extension off an existing enterprise/corporate system. The owner will provide all modifications to integrate new AXIS cameras into existing software.

- 14) **What Video Management System software is being used?**

Answer: The Owner will perform all modifications to the video Management Software.

- 15) **Will additional licensing be required for the Camera Surveillance System/Video Management System? If so, who will be providing them?**

Answer: No additional licensing required.
