**BID SCHEDULE:** (2<sup>nd</sup> **REVISED BID ITEM SCHEDULE ATTACHED**) – Please use the 2<sup>nd</sup> revised Bid Item Schedule in place of Pages 4-9 of the original Bid Document, previously replaced by Pages 3-8 of Addendum #1. Changes include:

Item 16.0 – NEW – Park Site Drainage Improvements. This is to include all excavation, storm drain piping, backfill, F.E.S., Yard Drains with 3' radius of 12" minus rip rap for complete site storm drain system.

Item A4.0 – DELETED – This item is part of Alternate B Dog Park option and is included in Bid Item B10.0

#### **CLARIFICATIONS:**

- 1. The Park Site drainage was missing from the Base Bid. Bid Item 16.0 is for the Park Site drainage which will include all excavation, backfill, piping, yard drains with 3' radius of 12' minus rip rap constructed around them, FES and all appurtenance necessary for the park site drainage as shown on the plans and to the back of curb tie in point to the playground drainage.
- 2. Base Bid Item 10.0 will be for the playground drainage system only to the back of curb where it ties into the site drainage of the park.
- 3. Alternate A4.0 is deleted from the bid schedule. This item is part of Alternate B Dog Park option and is covered in Item B10.0

Please note and adjust your bid according to the revisions, additions, deletions, clarifications or modifications as presented on this Addendum #2, which are made a part of this bid. NOTE: To avoid disqualification, this Addendum 2 (and any other addenda) must be signed by an authorized
