Questions provided by potential bidders as of 4/20/18, and answers provided by the City of Sparks:

Bidder Question #1

Who is responsible to supply Gate Way Module/Communication Module? If TMWRF is doing the DCS control wiring, termination and programming, this might want to be called out, or Owner provided to ensure it works with programming.

City Response #1

The Gate way module/communication module is to be supplied by the manufacturer. On Diagram 2/M5.1, there is a note that states that all DCS control wiring, termination, and programming will be completed by TMWRF.

Bidder Question #2

The system calls for a model ZT75VSD compressor which is air cooled, however the drawings indicate a water cooled machine. This would be the ZR75VSD. Please confirm this is a water cooled compressor requirement. 460/3/60.

City Response #2

The compressor is to be a water-cooled compressor model ZR-75-VSD at 460/3/60.

Bidder Question #3

Piping is specified as Viega Propress. Is piping to be Sched. 5 or 10?

City Response #3

The Viega Pro-press piping is to be schedule 10.

Bidder Question #4

I see per section 28 of the special conditions that we need to include money for the building permit fee in our bid. Can you provide the amount of the building permit fee so we can include the correct amount in our bid?

City Response #4

Building permit is not required.

Bidder Question #5

Please provide information below regarding Flowmeter/Rotometer in order to get the proper sizing etc. Please provide preferred manufacturers if necessary.

City Response #5

Flowmeter is not required
