This addendum is to notify all potential proposers of clarifications made to the Bid documents as stated below.

REMINDER TO BIDDERS:

Due to issues discovered in previous bids for this and similar construction projects, the City wishes to direct bidders to re-read and observe the following items:

- 1) **Bid Document Page 8 (Subcontractor Detail)** Potential bidders are reminded that Nevada State Law REQUIRES bidders to list all subcontractors that will be paid an amount exceeding 5% of their bid price. This requirement extends to the bidder as well. Bidders MUST list themselves on this form with the description of work they will self-perform under any contract resulting from this bid. Bidders failing to list themselves on this form will be found "non-responsive" and cannot be considered in the evaluation of bids.
- 2) Turf System Warranty Requirements Potential bidders are recommended to thoroughly review the City's specifications concerning the warranty requirements for the installed turf system, found on Pages 56-57 of the bid document. The warranty requirements defined by the City vary from most "industry standard" warranty forms provided by turf manufacturers in their typical course of business. Bidders will find specific requirements concerning any potential exclusions as well as warranty requirements concerning continuing performance of the turf systems.

Questions provided by potential bidders as of 2/12/18, and answers provided by the City of Sparks:

Bidder Question #1

Can we provide a monofilament fiber as the full length grass blades and combine with a nylon thatch?

City Response #1

Insufficient information was submitted to consider and evaluate the question presented. The requirements to submit ALL relevant information and "*submit side by side evidence supported matrix*", as required by SECTION 32 18 13 – SYNTHETIC TURF Part 2, 2.1, A through D of the project manual was not received.

SECTION 32 18 13 - SYNTHETIC TURF Part 2, 2.1

D. In order for each equivalent product submission to receive an appropriate and expeditious review, all relevant data for the proposed equivalent product shall be submitted for City review. This must include all detailed product data, performance testing, and warranty. The contractor must generate and submit a side by side evidence supported matrix comparing all items/categories detailed in this specification Part 1- General; 1.5 Submittals: Item D – No. 1, 2 &4 and Part 2- Materials; 2.2 Synthetic Turf Minimum Product Requirements. Failure to provide a clear, comprehensive, and summarized matrix, supported by testing and or performance data will result in a rejection of the submission.

No technical information was received, therefore the request is rejected.

Bidder Question #2

Please review our request for a substitute for the nylon thatch fiber specified. It's finished length will be 0.85 inches for the 1.7" height system.

City Response #2

Insufficient information was submitted to consider and evaluate the nylon thatch fiber presented and would need to be considered as a part of a comprehensive submission for the synthetic turf carpet. The requirements to submit ALL relevant information and "submit side by side evidence supported matrix", as required by SECTION 32 18 13 – SYNTHETIC TURF Part 2, 2.1, A through D was not received.

Insufficient and incomplete information was received, therefore the request is rejected.

Bidder Question #3

Please review MonoSport MT60 1.5 FL457 as an approved equal or alternate substitution.

City Response #3

Insufficient information was submitted to consider and evaluate the synthetic turf carpet presented. The requirements to submit ALL relevant information and "*submit side by side evidence supported matrix*", as required by SECTION 32 18 13 – SYNTHETIC TURF Part 2, 2.1, A through D was not received.

Insufficient and incomplete information was received, therefore the request is rejected.

Bidder Question #4

Please consider Envirofill, an acrylic coated sand that is coated with Microban and can be used for multiple turf life cycles and/or, an organic product made of Black and English walnut shells that offers evaporative cooling features as alternate in-fill materials to the crumb rubber specified.

City Response #4

Insufficient information was submitted to consider and evaluate the synthetic turf carpet presented. The requirements to submit ALL relevant information and *"submit side by side evidence supported matrix"*, as required by SECTION 32 18 13 – SYNTHETIC TURF Part 2, 2.1, A through D was not received.

No technical information was received, therefore the request is rejected.

Bidder Question #5

Please consider ThermaGreen 15 (SportsLite HD15SL-NW3-S) as an equivalent shock pad to the specified materials.

City Response #5

Insufficient information was submitted to consider and evaluate the synthetic turf carpet presented. The requirements to submit ALL relevant information and "submit side by side evidence supported matrix", as required by SECTION 32 18 14 – ATHLETIC FIELD SHOCK ATTENUATION PAD Part 2, 2.1, A through D was not received.

Insufficient and incomplete information was received, therefore the request is rejected.

Bidder Question #6

Please consider Vintage 40-55 (Field Turf Slit-Film w/Thatch 1.6 inches) as an equivalent to the specified synthetic turf carpet.

City Response #6

Insufficient information was submitted to consider and evaluate the synthetic turf carpet presented. The requirements to submit ALL relevant information and *"submit side by side evidence supported matrix"*, as required by SECTION 32 18 13 – SYNTHETIC TURF Part 2, 2.1, A through D was not received.

Insufficient and incomplete information was received, therefore the request is rejected.
