NOTICE IS HEREBY GIVEN that the City of Sparks, Nevada, will receive written sealed bids only, for the project listed above. Said bids must be in the hands of the Contracts and Risk Manager at 431 Prater Way, Sparks, Nevada, **NO LATER THAN 3:45 PM ON DECEMBER 19, 2019**. Bids postmarked prior to, but not received until after this deadline will not be accepted. Vendor bid response submittals may not be sent to the City of Sparks via the Internet/e-mail and will not be entertained for award by the City of Sparks. The right is reserved to reject any Bid/Proposal or to accept the Bid/Proposal which is deemed by the City of Sparks to be in the best interest of the City of Sparks. The City of Sparks reserves the right to waive any irregularities and/or informalities in the bid process.

All Bids are to be marked clearly on the outside. Bids will be opened and publicly read at **4:00 PM ON DECEMBER 19, 2019**, at Sparks City Hall, 431 Prater Way Sparks, NV 89431.

PROJECT DESCRIPTION: Construction/Installation of a monolithic pavement “Cushion Court” tennis court system consisting of three (3) individual courts (2-Tennis and 1-Pickle Ball) made up of a base sheet of synthetic fibers and fabric interlocked with select aggregates, synthetic polymers, and flexible acrylic finishing materials (Nova’ ProBounce or equivalent product) over the existing asphalt tennis court surface with new Tennis Court and Pickle Ball striping to be applied to both courts OR removal of existing tennis court surface and AC, reconditioning of base, installation of 3” of new Type 3 AC, and tennis court surfacing, with new Tennis Court and Pickle Ball striping to be applied to both courts and all appurtenant work necessary to complete the project as stated in the bid specifications.

PRE-BID MEETING: There will be a **NON-MANDATORY** pre bid meeting held at 8:30AM on December 9, 2019 at the project site, Burgess Park Tennis Courts, 1605 Pyramid Way, Sparks NV 89431.

BONDING/LICENSING: A Bid Bond in the amount of 5% of bid amount is required. This bid bond will function as a penalty in the event the successful bidder fails to enter into a written contract with the City in accordance with the bid documents. Additionally, the City will be entitled to actual damages, if any. Prospective bidders will be required to have a current Contractor’s License under the Nevada State Law for the type of work specified herein.

The work to be performed under this Contract shall be commenced by the successful Bidder after all executed Contract documents have been submitted, and after being notified to proceed by the City of Sparks.

There is no cost to use the system or obtain plans, but registration at the site is required.
