1. Included in the revised set of drawings/plans are the Sparks Police Department record drawings for the basement, ground floor, and second floor levels reflected ceiling plans.

RFI QUESTION REPONSES:

- 1. Sheet E0.2 'BLB' Panel Schedule shows a New Exhaust Fan. Nothing is Shown on the Floor Plans?
 - a. The proposed new exhaust system in the basement evidence property & storage room was omitted from the plans. The new exhaust fan noted on Panel "BLB" circuit breaker 18 of the plan set (Sheet E0.2) was removed from the new plan set provided above.
- 2. Sheet E1.1 Note 2 has us Removing the Lighting and Switching. E2.1 does not show the New Lighting?
 - a. With removal of the proposed new exhaust fan system in the basement evidence property & storage room from the project (see prior question) therefore the evidence office will

remain a drop ceiling and the lighting will remain in the current configuration. Contractor will remove and replace the drop ceiling within the evidence office as needed to remove and replace the proposed duct work modifications. The evidence office demolition showing the removal of the lighting and switches that was on Sheet E1.1 has been removed. Sheet E2.1 was previously revised to not show the new lighting. Refer to new revised Sheet E1.1.

- 3. Sheet E2.1 Please Clarify Notes 3, 4, 5, 6 and 7? Not shown on Floor Plan?
 - a. Notes 3, 4, 5, 6, and 7 on Sheet E2.1 has been removed. The notes were for the improvements within the Evidence office that was removed from the project as noted in the previous questions. Refer to new revised Sheet E2.1.
