REMINDER TO BIDDERS:

RFI RESPONSES

Question #1:

Can you clarify within bid item 8 and 9 clarification whether the project intention is to supplement existing base or replace existing base?

Response:

Please reference bid item 8 and 9 revised clarification.

Question #2:

In the pre-bid the engineer said the only NDOT paving was a small area behind the curb. Is the intent to pour the curb and gutter neat with the existing asphalt on Pyramid Highway to prevent any curb patching? **Response:**

Yes, the intent is to neat form remove and replace the existing curb and gutter with minimal disturbance to Pyramid Highway.

Question #3:

If a lane closure is required on Pyramid Way, does the City think NDOT will require that work to be performed at night?

Question #4:

In reference to Bid Item 21 Signs (NDOT), the plans do not show any signs in NDOT ROW being installed, Removed or replaced. What 3 specific signs is the City wanting to be installed?

Please refer to revision one on sheet S-1 on the civil plans and sheet 1 on the NDOT Encroachment Permit plans.

Question #5:

Can we get a copy of the NDOT permit? **Response:** The NDOT permit is currently still being processed.

Bid Item 9 – Construct Asphalt Paving (NDOT)

This item shall include constructing asphalt paving as indicated on the plans. The work comprising the unit bid price for this item shall include all labor, equipment, materials and incidentals necessary to construct asphalt paving as indicated on the plans, including, but not limited to; installation of asphalt and aggregate base as needed per direction of the CITY per details on the plans.

The final pay quantity shall be by square foot. Payment for CONSTRUCT ASPHALT PAVING (NDOT) shall be made at the applicable unit price bid per square foot, which shall be deemed full compensation to complete the work as specified.
