AREA OF ABANDONMENT

All that certain parcel situate within a portion of the Southwest One-Quarter (SW 1/4) of Section Five (5), Township Nineteen (19) North, Range Twenty (20) East, Mount Diablo Meridian, City of Sparks, County of Washoe, State of Nevada, being the parcel as shown on Reversion Tract Map No. 3836, as File No. 2450111, filed on May 25, 2000, in the Official Records of Washoe County, Nevada, said parcel being more particularly described as follows:

BEGINNING at the southwest corner of the Parcel as shown on Reversion Tract Map No. 3836, said point being the intersection of the northerly right-of-way line of "C" Street and the easterly right-of-way line of 21st Street, as shown on said Reversion Tract Map No. 3836, from which the southwest corner of said Section 5 bears South 04°54'30" West, 531.33 feet;

THENCE along said northerly right-of-way line of "C" Street, South 88°55'36" East, 174.93 feet, to the southeast corner of said parcel, being the intersection of the northerly right-of-way line of said "C" Street and the westerly right-of-way line of 20th Street, as shown on said Reversion Tract Map No. 3836;

THENCE along said westerly right-of-way line, North 01°04'11" East, 181.50 feet;

THENCE leaving said westerly right-of-way line South 88°55'49" East, 8.86 feet, to the back of sidewalk on said 20th Street:

THENCE along the back of sidewalk on said 20th Street South 01°02'50" West, 157.92 feet;

THENCE continuing along said back of sidewalk, South 02°29'07" West, 24.14 feet, to the beginning of a curve to the right;

THENCE leaving said back of said walk on 20th Street, along the back of sidewalk,17.03 feet along the arc of a 11.00 foot radius curve, through a central angle of 88°43'36", to the back of sidewalk on the above mentioned "C" Street;

THENCE along said back of sidewalk the following five (5) courses:

- 1) North 88°59'40" West, 100.17 feet,
- 2) North 89°00'48" West, 16.78 feet,
- 3) North 86°26'17" West, 9.42 feet,
- 4) North 89°15'38" West, 42.85 feet and,
- 5) South 00°44'22" West, 0.87 feet;

THENCE leaving said back of said walk on "C" Street, along the back of sidewalk, along a non-tangent curve to the right from which the radius point bears North 03°59'47" West, 19.06 feet along the arc of a 11.50 foot radius curve, through a central angle of 94°58'40", to the back of sidewalk on the above mentioned 21st Street;

THENCE along the back of sidewalk on said 21st Street North 00°58'53" East, 133.77 feet;

THENCE leaving said back of walk South 88°56'22" East, 9.68 feet, to the westerly line of said Parcel as shown on Reversion Tract-Map No. 3836, being the easterly right-of-way line of said 21st Street:

THENCE along said westerly line of said Parcel and the easterly right-of-way line of 21st Street, South 01°03'38" West, 133.08 feet, to the above mentioned Point of Beginning of this description;
