AN ORDINANCE BY THE CITY OF SPARKS AMENDING CHAPTER 15 OF THE SPARKS MUNICIPAL CODE TO ADOPT THE 2012 INTERNATIONAL ENERGY CONSERVATION CODE (IECC) AND THE 2015 NORTHERN NEVADA ENERGY CODE AMENDMENTS REGULATING ENERGY EFFICIENT BUILDING ENVELOPES AND INSTALLATION OF MECHANICAL, LIGHTING AND POWER SYSTEMS; AND PROVIDING FOR OTHER MATTERS PROPERLY RELATED THERETO.

THE CITY COUNCIL OF THE CITY OF SPARKS DOES ORDAIN:

SECTION 1:

Section 15.05.100 - Adoption.

The City of Sparks adopts the following codes:

6. 2012 Edition of the Uniform Mechanical Code (UMC), chapters 2 through 17 together with Appendix Chapters A, B and C.

**SECTION 2:** All ordinances or parts of ordinances in conflict herewith are hereby repealed.

**SECTION 3:** The City Clerk is instructed and authorized to publish the title to this ordinance as provided by law and to record the plan certified herein as provided by law.

**SECTION 4:** This ordinance shall become effective July 1, 2016 upon passage, approval and publication.

**SECTION 5:** The provisions of this ordinance shall be literally construed to effectively carry out its purposes in the interest of the public health, safety, welfare and convenience.

**SECTION 6:** If any subsection, phrase, sentence or portion of this section is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions.

**SECTION 7:** The City Council finds that this ordinance is not likely to impose a direct and significant economic burden upon a business or directly restrict the formation, operation or

expansion of a business, or is otherwise exempt from Nevada Revised Statutes Chapter 237.
