- 2. Three (3) SoftwareHouse i-Star Edge two reader controller.
- 3. Two (2) SoftwareHouse i-Star Edge four reader controller.
- 4. Two (2) SoftwareHouse i-Star Pro sixteen reader controllers.
- 5. Twenty Nine (29) SoftwareHouse RM style multi-technology readers with keypads.
- 6. This upgrade will utilize all existing power supplies, locks, door contacts, request to exit devices and cabling.
- 7. One Hundred (100) 125kHz proximity cards for use with the new SoftwareHouse readers.
- 8. Labor to program new hardware into C-Cure 9000. All cardholder programming to be performed by the customer.
- 9. Labor to test and verify function of installed devices.

- 5. The SoftwareHouse RM reader will read the following card formats: ISO 14443 A/B, ISO 15693, iCLASS (SN only), MIFARE, DESFire®, FIPS 201 PIV II, and most 125 KHz formats (HID and CASI® ProxLite).
