6.2 Consideration, discussion, and possible approval of an expenditure of \$293,667.80 to purchase high security, safety barricades and bollards for the Downtown Safety Barricades Project – Phase 1 from Delta Scientific, utilizing a joinder with the GSA contract number 47QSWA18D003B. (FOR POSSIBLE ACTION)

An agenda item from Assistant City Manager John Martini and presented by Sparks Police Chief Pete Krall and Transportation Manager Amber Sosa requesting Agency approval of an expenditure of \$293,667.80 to purchase high-security safety barricades and bollards for the Downtown Safety Barricades Project – Phase 1 from Delta Scientific, utilizing a joinder with the GSA contract number 47QSWA18D003B. The equipment is a combination of an in-ground barricade system, two mobile barricade systems, and fixed and removable bollards.

Council asked if the team is aware funds were appropriated from Tourmark to be used for this purpose; Chief Krall confirmed they are aware of about \$100,000. Council asked about the purpose of fixed bollards toward parking lot openings, if access to 10th Street is accounted for, and how many phases there are. Mrs. Sosa explained the bollards protect from small vehicle threats while still offering ADA clearance compliance; currently bollard placement is dedicated to suggested areas and can be moved all the way to 15th Street as needs are assessed; and pilot implementation will help determine how many phases the project will encompass. Council thanked the team for their dedicated research, extensive work, and great use of funds.
