

Amendment No. 1 to
Cooperative (Local Public Agency) Agreement No. P539-17-063

This Amendment is made and entered into on _____, between the State of Nevada, acting by and through its Department of Transportation, hereinafter referred to as the "DEPARTMENT", and the City of Sparks, 431 Prater Way, Sparks, Nevada 89431, hereinafter referred to as the "City."

WITNESSETH:

WHEREAS, on March 1, 2018, the Parties entered into Agreement No. P539-17-063 to install audible pedestrian push buttons for crosswalk activation; and

WHEREAS, the termination date must be amended due to a delay of construction because of inclement weather; and

WHEREAS, the parties hereto desire to make certain amendments to Agreement No. P539-17-063.

NOW, THEREFORE, the parties agree as follows:

- A. The termination date referenced in Article III, Paragraph 1, shall be changed from June 30, 2019 to June 30, 2020.
- B. Article III, Paragraph 14, is amended by deleting it in its entirety and inserting in its place:

14. All notices or other communications required or permitted to be given under this Agreement shall be in writing and shall be deemed to have been duly given if delivered personally in hand, by telephonic facsimile or electronic mail with simultaneous regular mail, or mailed certified mail, return receipt requested, postage prepaid on the date posted, and addressed to the other party at the address set forth below:
