Current (4/30/12) by-laws state "A public body may appoint one or more alternate Commissioners from among its members to attend a Commission meeting and vote if one or more of the Commissioners appointed by that Public Body are unable to attend a Commission meeting. The Public Body may (i) appoint an alternate to attend one Commission meeting in the place of one of their Commissioners, (ii) appoint an alternate to substitute for one of their Commissioners for the term of the Commissioner, (iii) choose which of the designated alternates shall attend a particular Commission meeting or designate a method for choosing which alternate(s) will attend a Commission meeting, or (iv) rank alternates or assign alternates to attend Commission meetings on a rotating basis. The Public Body may remove and replace alternates.
