The State of Nevada, Division of Purchasing OR the contractor (successful bidder) shall reserve the right of cancellation of any item or items hereinbefore specified and bid on provided such cancellation is for cause and given in writing by either to the other 10 days prior to cancellation. Cause shall be defined as change in price to the general public, increase in freight rates, poor delivery, etc.

This contract is primarily for use by the Nevada Department of Transportation, however, orders may be placed by the Nevada State Purchasing Division or other State agencies, Cities, Counties or political subdivisions should the need arise

Material is to be delivered in truckload lots (approximately 25 tons) and packaged in two 25 lb. or 30 lb. blocks per box or in 5 gallon sealed containers on NON-RETURNABLE wood pallets. The material shall be capable of being melted and applied to joints and cracks at a temperature below 400F. and shall be guaranteed flash free at a temperature of at least 20 degrees Fahrenheit above the recommended application temperature. Containers shall have internal polyethylene liners and the maximum safe heating temperature of the product shall be indicated on the exterior of all containers. Heating and application instructions shall be furnished with each shipment.
