An agenda item from Assistant City Manager John Martini and presented by TMWRF Plant Manager Michael Drinkwater requesting approval of agreement (AC-5577) with Brown and Caldwell for construction management services for the TMWRF Nitrification Tower 2 Rehabilitation Project in an amount not to exceed \$751,746, with City of Sparks' share being \$235,822.72. The City of Reno and the City of Sparks share the cost of this project based on the pro-rata ownership of TMWRF. The ownership split is currently 68.63 percent for Reno and 31.37 percent for Sparks.

Council requested clarification on the budget process for the project. Mr. Drinkwater explained these types of projects are funded through the Sewer Enterprise Fund, and a portion of sewer payment fees are dedicated to this fund for repairs. Mr. Drinkwater reiterated each City's financial contributions are based on ownership percentages.

Council asked about the project timeline and repercussions if the deadline is not met; Mr. Drinkwater stated there is a 6-month construction window. Upon approval of the contract, the procurement phase will begin and when all materials are procured and assembled at the treatment plant a 6-month deadline would begin for construction completion. Failure to meet the construction deadline would extend tower recovery into winter, leading to potential biological recovery issues and possible permit violations.
