7.1 Boards and Commissions vacancy announcement: Building Code Board of Appeals

City Manager Neil Krutz announced two (2) vacancies on the Building Code Board of Appeals. Applicants must be a registered professional with architectural experience, or a builder or superintendent of building construction with at least 10 years of experience (five (5) of which must be in responsible charge of work. 8.2 Consideration, discussion, and possible acceptance of a 2020 Justice Assistance Grant award from the U.S. Department of Justice in the amount of \$32,251.00. (FOR POSSIBLE ACTION)

An agenda item from and presented by Chief of Police Chris Crawforth requesting Council approval to accept a 2020 Justice Assistance Grant (JAG) award from the U.S. Department of Justice in the amount of \$32,251.00. The U.S. Department of Justice, Office of Justice Programs, Bureau of Justice Assistance awarded the grant collectively in the amount of \$161,256.00 to the Reno Police Department, Washoe County Sheriff's Office, and Sparks Police Department. This funding can be used towards law enforcement training, equipment, and personnel overtime expenses.

Due to supply chain interruptions caused by the COVID-19 pandemic, police vehicle availability was compromised. With time being of the essence the City Manager approved the vehicle purchase February 2, 2021, and a purchase order was issued on February 3, 2021. Council asked when the vehicles are expected to join the fleet; Mr. Anderson confirmed early Fall 2021 as long as the supply chain allows.

9.2 Consideration and possible approval of an expenditure of \$292,277.00 to purchase one Schwarze Model M6TE Avalanche Mechanical Sweeper on a Freightliner M2 chassis from Schwarze Industries, Inc., utilizing Sourcewell contract #122017-SWZ and MME Equipment. (FOR POSSIBLE ACTION)

An agenda item from Assistant City Manager John Martini and presented by Public Works Manager Ron Korman requesting Council approval of an expenditure of \$292,277.00 to purchase one Schwarze Model M6TE Avalanche Mechanical Sweeper on a Freightliner M2 chassis from Schwarze Industries, Inc., utilizing Sourcewell contract #122017-SWZ and MME Equipment. The existing sweeper has reached the end of its useful service life and needs replacement due to high maintenance costs. Public Works Maintenance utilizes sweepers daily to remove debris and dirt from City streets, alleys, and trails. Council asked when another machine might be needed to keep up with expansion in the city. Mr. Korman noted there are extra sweepers available in the fleet to help with upkeep. Another machine would potentially necessitate an additional employee, which is not feasible at this

time. Mr. Korman noted they do not anticipate the need for an additional sweeper soon but will continue to monitor the situation.

An agenda item from and presented by Fire Chief Jim Reid requesting possible direction to apply for a FEMA Staffing for Adequate Fire and Emergency Response (SAFER) grant to hire three firefighters for three years. The SAFER grant is a three-year grant that fully funds the salary and benefits of each employee. Sparks Fire Department will be required to purchase the necessary firefighting equipment for these employees and guarantee employment for those three years. The grant application period opened in February and closes March 12, 2021. Notification of award normally occurs in late summer or early fall.

An agenda item from Assistant City Manager John Martini and presented by Transportation Manager Amber Sosa requesting Council approval of the 2021 Street Rehabilitation – Unit 1 – Camino Real Drive Neighborhood, Bid No. 20/21-007, PWP-WA-2021-132 construction contract (AC-5737) to Sierra Nevada Construction in the amount of \$1,086,007.00. On February 10, 2021, the City of Sparks received five qualified bids for this project. Sierra Nevada Construction submitted the low bid in the amount of \$1,086,007.00. The project involves removing and replacing deteriorating curb, gutter, sidewalk, and driveway approaches, along with constructing new pedestrian ramps and reconstructing the roadway with new asphalt.

Proposed amendments primarily address changes needed to conform to the 2019 Truckee Meadows Regional Plan. However, general updates and a limited number of targeted policy changes are also included. On November 5, 2020, the Sparks Planning Commission approved the proposed amendments to the Sparks Comprehensive Plan. On January 28, 2021, the Truckee Meadows Regional Planning Commission found these amendments to be in conformance with the Regional Plan.

Council asked for clarification on the Primary Investment Quarter. Ms. Reed explained the new name is essentially a rebranding intended to encourage a variety of investment options that are not limited simply to bus transit improvements. A variety of investment types allows for greater flexibility in how the space along the corridor is used. Ms. Reed noted the goal is to continue to encourage more vibrant, urban settings along the corridor.

Public hearing was opened at 3:07 p.m. There were no comments.
