Dear Clerk Hunderman, please read into the record.

Dear Sparks Council Members,

**Puppy Mill Free Sparks** has accrued nearly **20,000 signatures**, mostly local hardcopies, since 2013, at events like **Paws on the Plaza** at Victorian Square and **Walk for Animals** at the Marina. Nevada Humane Society had us as the first booth to get as many signatures as possible. NHS and SPCA alone helped secure over 3000 signatures.

We believe your constituents want an ordinance to end puppy mill store cruelty in Sparks. We have met and are engaged in conversations with Council Members Abbott and Bybee. We are looking forward to speaking with Member Lawson and Manager Krutz this Thursday.

Members Anderson and Dahir: we are hoping to schedule meetings with you to present our case which has so much support from the community. We have a lot of background documents and video exposés to share with you.

Over <u>400 cities</u>, counties states and even the entire country of England have passed the same ban your constituents are asking for to end the systematic abuse found throughout the Puppy Mill Store pipeline: from large-scale breeding facilities ("mills" or "farms") to the backrooms of stores exposed numerous times over the years by news reports over the last decade.

As Member Anderson said after the Washoe County Regional Animal Services Advisory Board Meeting when he heard testimony from a former employee, "I had no idea that kind of thing was going on there."

We look forward to meeting with you all and to a speedy introduction of an ordinance to end these reprehensible animal cruelty and consumer fraud issues, noted through the store's long-standing "F" rating from the Better Business Bureau, (7 years since we've been tracking).



Hi my name is Hanna Ratliff, I worked at Puppies Plus for over a year. The amount of animal cruelty I witnessed while working there was emotionally and physically heart breaking. These puppies that were being sold were treated like products instead of a living being. The puppies came in from puppy mills, they were sick, abused, and neglected. Some puppies would come in extremely sick and would die over the night. While working there,

# I witnessed illegal medications given. I witnessed the failure from the owners to get the puppies the proper veterinarian care they deserved.

The puppies were kept in small cages, some cages had more than 3 puppies in them. The puppies drank out of a small rabbit water dispenser. The cages had torn up tissue paper, and they would eat the paper and they would lay in their own fecal matter. The puppies would also eat their own feces causing long term affects.

In October of 2018, I rescued one of the puppies from this horrid place. He is a cocker spaniel/cavalier King Charles mix. He was there for 5 months, in that tiny cage. I paid a lot of money to rescue him. He contracted Giardia (Giardia is a parasite you can contact from dirty water, or eating feces, it can be passed from

dogs to humans by letting the dog lick your face) because the other employees never wanted to clean out the cages.

I also contracted Giardia from working there I was in the Emergency room for 6 hours and the owners did not pay for my medical expenses.

Also, while working there, I was given a yellow Labrador retriever for free. She had a stage 3 heart murmur, the owners Michael and Leilani Schneider did not want to pay for her medical expenses. I took the yellow lab home and fostered her for a couple days and gave her to a family friend who payed for all her veterinarian care. The vet told us that will she only live to be 3 years old because of her condition.

When the puppies would arrive they would smell like they were marinating in their own urine and feces they were dirty and hungry, some barely able to stand up.

While working at Puppies Plus, I went through a traumatic experience, *over 15 puppies died while I was working there*.

Most of these puppies would die in my arms because Michael and Leilani Schneider failed to come get the puppies and take them to the vet. They would wait days to come look at the puppies, and they would tell us "I think they are okay, just give them sugar water and they will be fine."

After the puppies would die she would instruct us to wrap the puppy in a trash bag and leave the puppy in the back until they would come pick them up. Also *if a puppy was sick we were told not to call any type of vet or take the puppies to the vet clinic*. In the back of the store there are cages where they would keep sick puppies, so the public wouldn't seem them. The puppies would sit in the cages until they got better, or *they would die slowly because the owners refused to take them to the vet*.

Moving forward, puppy stores should not continue to exist and Puppies Plus and Puppy Love should be shut down so no more innocent puppies suffer from the cruelty and torture these owners are causing.

We also need to protect people from consumer fraud. How many more puppies have to lose their lives before we make a difference so please help make this ban on puppy stores go into full affect so we can save the lives of puppies everywhere.
