SIXTH AMENDMENT TO AGREEMENT FOR SERVICES BETWEEN WELLCARE SERVICES RENO, LLC, THE CITY RENO, THE CITY OF SPARKS, WASHOE COUNTY, and WASHOE COUNTY HEALTH DISTRICT

WHEREAS the Parties to this Amendment are Parties to an Agreement for Services dated on or around March 30, 2020 ("Agreement"), which was extended in writing in May 2020 to June 27, 2020, in June 2020 to October 30, 2020, on October 23, 2020 to December 30, 2020, and amended again in November 2020 to alter the number of beds to be provided by WellCare until December 30, 2020, then amended once again to reduce the number of beds in December 2020 to extend through April 30, 2021, and other amendments described therein; and

WHEREAS the Parties seek to again amend the Agreement pursuant to Section 6.15, which allows amendments in writing executed by all Parties with the same formalities by which the Agreement was executed, to amend the term of the Agreement from April 31, 2021 through October 31, 2021 (183 DAYS) and to reduce the number of beds to a total of 5 beds at a cost of \$100.00 per day per bed regardless of use, and to make other changes as described herein;

NOW, THEREFORE, in consideration of the foregoing premises and the following covenants, terms and conditions, the Parties do hereby agree as follows:

- 1. The Parties hereby amend the Agreement as follows:
- A. The term of the original Agreement shall be extended to October 31, 2021. Additional extensions may be granted in a writing signed and executed by all Parties with the same formalities by which the Agreement and this Amendment and Extension were executed.
- B. Effective May1, 2021, and concluding on October 31, 2021, WELLCARE SERVICES shall be required to provide a total of 5 beds at a cost of \$100.00 per day, per bed, regardless of the number of beds actually used by the AGENCIES. WELLCARE SERVICES shall also provide additional "overflow" beds to the AGENCIES on an as-needed basis at a cost of \$100.00 per day, per bed, which is actually used by the AGENCIES.
- C. The AGENCIES agree to pay a one-time \$240.00 cleaning fee for any of the "overflow" beds that are actually used.
- D. The maximum aggregate amount for the 5 beds agreed to in this Amendment incurred by the AGENCIES for the period from May 1, 2021 to October 31, 2021, shall not exceed \$\$100,000. No expenditures beyond the \$\$100,000 are authorized or will be made unless AGENCIES first approve any such additional expenditures by approval of the appropriate AGENCIES' representatives.
 - E. Section 1.5 of the original Agreement shall be modified to as follows:

WELLCARE SERVICES intends to provide these services at one or more of the existing Well Care locations; the Incident Management Team has identified the use of Well Care's facilities for surge capacity as an emergency protection measure.

2. There are no other amendments not described in this Sixth Amendment. To the extent any terms or conditions in this Sixth Amendment conflict with any terms of the Agreement or a previous Amendment, the terms of this Sixth Amendment shall supersede, replace, and prevail over those terms.
