7. Announcements, Presentations, Recognition Items and Items of Special Interest

7.1 Commendation: Coach Dickie Allen

A commendation from Mayor Smith recognizing Coach Dickie Allen for his long tenure of teaching and coaching in Nevada. In his career as an educator and coach, Mr. Allen won ten (10) state championships and has received a NIAA award and seventeen (17) regional and national coach of the year awards. Mr. Allen retired on February 13th, 2020 from Reed High School after 48 years of coaching.

7.2 Commendation: Excel Christian School

A commendation from Mayor Smith recognizing Excel Christian School for their Academic Olympic team. The Excel Christian School has participated in the Nevada State Meet for the last three years and recently won the 2019 1A Academic Olympic State Championships, the first in the school's history. The Commendation was read by Council Member Anderson and presented to the Academic Olympic team and Coach Debbie Green. Each team member spoke about their academic specialty. Council Member Dahir commented about the pride the team and coach bring to Sparks.

7.3 Proclamation: Professional Land Surveyor's Week

Mayor Smith proclaimed March 15th -20th, 2020 as Professional Land Surveyor's Week. The proclamation was read by Council Member Lawson and presented to National Land Surveyors Member Bob LaRiviere.

7.4 Presentation: Awaken

A presentation from the Awaken Prevention Coordinator Shontell Brewer. Awaken is a local organization dedicated to raising awareness and educating the public on commercial sex trafficking in the Truckee Meadows and provides housing and restoration for its victims.

City Attorney Adams asked about how the homeless community is involved in the sex trafficking issue. Ms. Brewer stated within forty-eight (48) hours of being on the street, males will be propositioned by traffickers and within twenty-four (24) hours females will be propositioned. These acts are typically being traded for drugs, food, shelter or protection. Foster care kids are also a high risk for sex trafficking

since they are often in between homes, however socio-economic status does not increase the risk one way or another.

City Attorney Adams asked how parents can get a better handle on this issue. Ms. Brewer stated becoming more informed by going to Awaken's website and presentations can help and being more careful with children's phone use.

Mayor Smith thanked Ms. Brewer and Awaken for raising awareness and the help they provide the community.

9.3 Consideration, discussion, possible input, and acceptance of the Regional Transportation Commission's presentation of the development of the 2050 Regional Transportation Plan (FOR POSSIBLE ACTION)

Council Member Lawson excused himself from the dais at 2:30 p.m.

An agenda item from Assistant City Manager John Martini and presented by RTC Interim Executive Director Amy Cummings requesting Council input from the City of Sparks on the development of the 2050 Regional Transportation Plan.

The Regional Transportation Plan (RTP) is the Regional Transportation Commission's (RTC) long-range transportation plan as required under Title 23, Part 450 of the Code of Federal Regulations (CFR). It contains major transportation projects and programs for Washoe County for all modes of travel. It functions as the major tool for implementing long-range transportation planning. The RTP aims to capture the community's vision of the transportation system and identifies the projects, programs and services necessary to achieve that vision that will be implemented by RTC, member entities, and NDOT.

Mayor Smith asked for an update on Sparks bus stops. Ms. Cummings stated the first batch of bus stop improvements are currently under construction and clarified that the improvements also include sidewalk connection to the stops themselves.

Mr. Dahir asked for an update on extended transit through Sparks. Ms. Cummings stated an additional flex ride service area in north Sparks and Spanish Springs is a priority in RTC's budget for this fiscal year. She also stated the number of people who are currently using the flex ride program in the area has tripled. Spanish Springs should have the Flex Ride service available by late summer/early fall of this calendar year.

Mayor Smith asked for a summary of the flex ride program. The program is similar to a ride-share app. The rider can use the RTC app or call RTC to request a ride from an RTC access driver. The driver will pick you up and take you anywhere within the designated zone you are picked up from. If the destination is outside of your zone, the driver will take you to Centennial Plaza where you can access other drivers to other zones.

Council Member Abbott asked when the RTP will be adopted. Ms. Cummings stated it will be adopted at the end of the calendar year.

Council Member Bybee asked if the RTP contains any pedestrian safety improvements. Ms. Cummings stated the reconstruction projects such as the Pyramid Highway and Sparks Boulevard projects will include multi-use paths for pedestrians and bicyclists as well as additional safety measures for pedestrians. The RTC and the City of Sparks are part of the Vision Zero Task Force which prioritizes communication and outreach to the public regarding safe transportation practices for drivers and pedestrians.

An agenda item from Assistant City Manager John Martini and presented by Public Works Manager Ron Korman requesting approval to purchase one 2021 International HV607 truck with grapple crane and debris box to be utilized in maintaining the appearance of the City. Over the last several years, Public Works

has seen a dramatic increase in the amount of trash, mattresses, couches, boats, cars, motorhomes, and human waste left in rights of way, parks, trails and other areas around the City. This truck staffed with two people can rapidly respond to a variety of different clean-up operations and can remove trash and debris before it gets into the storm drain system and river without the need for additional equipment or risking staff injury. If approved, the City will joinder with the City of Reno contract # 2018-00000596. \$366,541.00 was included in the Fiscal Year 2020 budget approved by the City Council on May 28, 2019.

11. Planning and Zoning Public Hearings and Action Items

11.1 Second Reading, Public Hearing, discussion and possible adoption of Bill 2773 to amend Title 20, Chapter 20.03.020 (Home Occupations), of the Sparks Municipal Code to add or revise standards pertaining to hours of operation, the number of permits allowed per dwelling unit, permitted uses, and standards and procedures for revocation of Home Occupations permits. (CA-4-19) (FOR POSSIBLE ACTION)

A request from Planning Manager Jim Rundle requesting Council adoption of Bill 2773 to amend Title 20, Chapter 20.03.020 (Home Occupations), of the Sparks Municipal Code to add or revise standards pertaining to hours of operation, the number of permits allowed per dwelling unit, permitted uses, and standards and procedures for revocation of Home Occupations permits. (CA-4-19).

A Home Occupation Permit (HOP) may be issued in the City of Sparks to provide residents the opportunity to work from home in a manner that does not compromise the integrity of a residential zoning district. SMC 20.03.020 provides a mechanism for a person to conduct a business within a dwelling unit provided the business is clearly secondary and incidental to the residential use. SMC 20.03.020(C)(3) would provide the Administrator the ability to revoke the HOP if the applicant violates any standard provided in SMC 20.03.020.

Council Member Anderson asked for clarification on the changes to standard B7. Mr. Rundle stated for a HOP, signage advertising for the business is not allowed

outside the residence. However, if the HOP has been approved through the Bureau of Alcohol Tabaco, Firearms and Explosives (ATFE) for conducting certain businesses, a sign must be posted outside the residence stating so.

Public Hearing was opened at 2:58 p.m. Elise Weatherly thanked Mr. Rundle for his presentation.
