RE: REQUEST FOR EXTENSION OF TIME FOR TENTATIVE MAP PCN04051 (MIRAMONTE)

Dear Mr. Martini:

This letter constitutes a formal request to the City of Sparks for an extension of time for Tentative Map PCN04051, otherwise known as Miramonte, per the provisions in Nevada Revised Statutes (NRS) 278.360. The Tentative Map was originally approved by the City of Sparks City Council on January 24th, 2005. Several successive final maps and time extensions have been requested and granted as follows:

- A one-year extension was provided due to City of Sparks City Council approval of and recordation of Miramonte Phase 1, recorded as Tract Map No. 4522, File No. 3250305 on July 25th, 2005.
- A one-year extension was provided due to City of Sparks City Council approval of and recordation of Miramonte Phase 2A, recorded as Tract Map No. 4616, File No. 3356268 on March 2nd, 2006.
- A one-year extension was provided due to City of Sparks City Council approval of and recordation of Miramonte Phase 3A, recorded as Tract Map No. 4641, File No. 3377446 on April 21st, 2006.
- A one-year extension was provided due to City of Sparks City Council approval of and recordation of Miramonte Phase 2B, recorded as Tract Map No. 4654, File No. 3393591 on May 30th, 2006.



- A one-year extension was provided due to City of Sparks City Council approval of and recordation of Miramonte Phase 3B, recorded as Tract Map No. 4770, File No. 3521804 on April 17th, 2007.
- A one-year extension was granted by the City of Sparks City Council on the 11th day of February, 2008.
- A one-year extension was provided due to City of Sparks City Council approval of and recordation of Miramonte Phase 4A, recorded as Tract Map No. 4915, File No. 3750177 on April 17th, 2009.
- A two-year extension was granted by the City of Sparks City Council on the 9th day of March, 2010.
- A two-year extension was provided due to City of Sparks City Council approval of and recordation of Miramonte Phase 4B Unit 1, recorded as Tract Map No. 5012, File No. 4102862 on the 13th day of April, 2012.
