## Hospital Services (NNMC) Participation Agreement

The purpose of this agreement is to set forth the working arrangements ("Agreement	") between the
Nevada Health Partners ("Coalition"), a Nevada non-profit corporation organized to secure	cost-effective
medical services for its Employer members, and	"Participating
Employer".	

## Recitals

- (a) Participating Employer is a member of the Coalition
- (b) Coalition has negotiated and made available to its Participating Employers and their respective employees, dependents and other eligible beneficiaries, a contract for hospital services with Northern Nevada Medical Center (NNMC) dated as of January 1, 2019 (the "Services Agreement"), to provide certain inpatient medical, surgical and other hospital care services through any health benefit program which an Employer might offer to its employees, dependents and other eligible beneficiaries.
- (c) Participating Employer desires the terms of the Services Agreement to apply to Participating Employer and its particular Plan pursuant to Section 1 of the Services Agreement.

It is therefore agreed:

- 1. <u>Definitions</u>. Capitalized terms used in this Agreement and not otherwise defined shall have the meanings ascribed to such terms in the Services Agreement.
- 2. Agreement. The Services Agreement shall apply to Participating Employer's Plan and participating Employer shall be (I) entitled to all the rights and remedies of a Participating Employer under the Services Agreement and (ii) obligated to perform all of the duties and obligations of a Participating Employer under the Services Agreement.
- 3. <u>Terms and Terminations.</u> Participating Employer may participate in the Services Agreement upon the execution of the Agreement. Participating Employer may terminate
