- Section 1. The fee table attached as Exhibit 1 shall be used as the basis for charging for services as of the effective date listed below.
- Section 2. **Effective Date**. This resolution shall be effective on October 11, 2011
- Section 3. **Repealer and General Provisions**. Any resolution which conflicts with this resolution I hereby repeal. The officers of the City are hereby authorized and directed to take all action necessary to effectuate the provisions of this resolution. The City Clerk is authorized to make editorial changes hereto consistent with the intentions of this resolution. The provisions of this resolution shall be liberally construed to effectively carry out its purposes. In the event that any provision in this resolution is deemed void, invalid or unenforceable by a court of competent jurisdiction, then such offending provision shall be served from this resolution and all the remaining provisions (including the repealer provision) shall remain in full force and effect.
