REGULAR CITY COUNCIL MEETING 2:00 P.M., Monday, March 25, 2013 City Council Chambers, Legislative Building, 745 Fourth Street, Sparks, Nevada

1. <u>Call to Order</u> (Time: 2:00 p.m.)

The regular meeting of the Sparks City Council was called to order by Mayor Geno Martini at 2:00 p.m.

2. Roll Call (Time: 2:00 p.m.)

Mayor Geno Martini, Council Members Ed Lawson, Ron Smith, Mike Carrigan, City Manager Shaun Carey, City Attorney Chet Adams and City Clerk Teresa Gardner, PRESENT.

Pledge of Allegiance (Time: 2:03 p.m.)

The Pledge of Allegiance was led by City Manager Shaun Carey.

Comments from the Public (Time: 2:03 p.m.) Mr. Gene Gardella spoke on gun violence.

5. Consent Items (Time: 2:28 p.m.)

5.1 Report of Claims and Bills approved for payment and appropriation transfers for the period February 21, 2013 through March 6, 2013. (FOR POSSIBLE ACTION)

An agenda item from Finance Manager Jeff Cronk recommending the City Council approve the report of claims and bills as presented in the staff report.

A motion was made by Council Member Smith, seconded by Council Member Lawson, to approve consent item 5.1 as submitted. Council Members Lawson, Smith, Carrigan, YES. Council Members Ratti, Schmitt, ABSENT. Passed unanimously with those present.

6. General Business

Consideration and possible approval of the Mayor's recommendation of appointment to the Western Regional Water Commission. (FOR POSSIBLE ACTION) (Time: 2:29 p.m.)

An agenda item from City Manager Shaun Carey recommending Council confirm the Mayor's recommendation of the appointment of Councilman Mike Carrigan to the Western Regional Water Commission. The current appointment will expire April 1, 2013. Councilman Mike Carrigan is the incumbent and is willing to serve another two year term.

Council Member Ed Lawson noted Council Member Mike Carrigan will term out in 2014 and asked if a new appointment would be made at that time, or in two years from now. Mr. Carey said Mr. Carrigan's appointment would end at the end of his term and a new appointment could be made at that time.

A motion was made by Council Member Lawson, seconded by Council Member Smith, to confirm the appointment of Councilman Mike Carrigan to the Western Regional Water Commission. Council Members Lawson, Smith, Carrigan, YES. Council Members Ratti, Schmitt, ABSENT. Passed unanimously with those present.

Review, consideration and possible approval of an extension of the Exclusive Negotiating Agreement between the City of Sparks, the Redevelopment Agency of the City of Sparks and AED Investments, LLC for the redevelopment of a 10.2 acre parcel owned by the Redevelopment Agency located on Marina Gateway Drive between East Prater Way and Lincoln Way and having Assessor's Parcel Number 037-020-50. (FOR POSSIBLE ACTION) (Time: 2:30 p.m.)

An agenda item from City Planner Armando Ornelas recommending the City Council approve the proposed extension f the Exclusive Negotiating Agreement. On September 24, 2012, the City Council and Redevelopment Agency Board approved a six month Exclusive Negotiating Agreement (ENA) with AED Investments, LLC. The ENA granted AED an exclusive opportunity to prepare a proposal to redevelop the a 10.2 acre parcel owned by the Redevelopment Agency located on Marina Gateway Drive for facilities which provide specialized services to the elderly and other complementary uses and, if the proposal is approved by the Agency, to acquire and redevelop the Property. This agenda item asks the City Council and Agency Board to consider and approve a six month extension of the ENA. There is no impact to the general fund.

Mr. Ornelas said AED Investments has agreed to complete their feasibility and market analysis of the project by May 10, 2013, which should provide the time necessary for the developer to determine support for the project and whether to proceed. The project will end on May 10, 2013 if AED's analyses indicates it would not be feasible to proceed with the project.

Council Member Ed Lawson asked if Mr. Ornelas was confident the 6-month extension was adequate. Mr. Ornelas said it was sufficient time.

Council Member Mike Carrigan asked Mr. Ornelas if anyone else has shown interest in the land. Mr. Ornelas said he has received a couple inquiries on the multi-family side, but nothing recently.

A motion was made by Council Member Lawson, seconded by Council Member Smith, to approve a six month extension of the ENA. Council Members Lawson, Smith, Carrigan, YES. Council Members Ratti, Schmitt, ABSENT. Passed unanimously with those present.

7. Public Hearing and Action Items Unrelated to Planning and Zoning

7.1 Second Reading of Bill No. 2655 amending Chapter 1 of the Sparks Municipal Code; to update the Nevada Revised statute from NRS 266.160 to the current applicable statute, NRS 268.014; and to update the publishing company for the Sparks Municipal Code from Book Publishing Company, Seattle Washington to Municipal Code Corporation, Tallahassee, Florida; providing other matters properly related thereto. (FOR POSSIBLE ACTION) (Time: 2:33 p.m.)

An agenda item from City Attorney Chester Adams recommending approval of Bill No. 2655. Section 1.01.010 of the Sparks Municipal Code relating to the Adoption of the Code has not been amended since 1974 and in that time the NRS concerning Codification of Ordinances and publications of codes has been repealed and moved to a different section of the NRS. The Code publishing company that the City of Sparks used has also changed. This ordinance is simply meant to update the Sparks Municipal Code. There is no impact to the general fund.

There were no comments from the public on this action.

A motion was made by Council Member Smith, seconded by Council Member Lawson, to approve and adopt Bill No. 2655, an ordinance amending SMC 1.01.010. Council Members Lawson, Smith, Carrigan, YES. Council Members Ratti, Schmitt, ABSENT. Passed unanimously with those present.

8. Planning and Zoning Public Hearings and Action Items

8.1 Public Hearing, 2nd Reading, discussion and possible action CA-6-12 of Bill#2651 an ordinance amending Title 20 of the Sparks Municipal Code to modify the expiration provisions for Special Use Permits (Chapter 20.13) and Site Plan Review (Chapter 20.31) and other matters properly relating thereto. (CONTINUED FROM THE 2/11/13 CITY COUNCIL AGENDA) (FOR POSSIBLE ACTION) (Time: 2:34 p.m.)

An agenda item from Senior Planner Jim Rundle recommending approval of CA-6-12 of Bill No. 2651. At a City Council meeting in 2012, the City Council directed that staff look at amendments to the development codes to remove barriers to development and job creation. This proposal would change the expiration date related to the approval of a use established by a Special Use Permit or Site Plan Review from one year to two years. There is no impact to the general fund.

This item was continued from the February City Council meeting to provide staff the opportunity to determine whether or not this item could be retroactive. After consulting with the City Attorney's office, staff believes this ordinance will not only apply to new Special Use Permits and Site Plan Reviews, but any approved Special Use Permits which have not yet expired.

Council Member Mike Smith asked for clarification of his understanding of the proposed expiration dates. Mr. Rundle confirmed the expiration dates and pointed to the document provided to Council which lists the ten special use permits which would be affected.

City Attorney Chet Adams asked Mr. Rundle if there was a specific retroactive date which could be applied to all ten entities. Mr. Rundle inspected the ordinance and read from Section 2, which indicated a finite date for retroactive expirations. Mr. Adams said he was okay with the terminology.
