The impacts of the pandemic have made already difficult conditions for at-risk populations worse and have exacerbated the need for centralized services. We commend Reno, Sparks and Washoe County for their regional cooperation and vision in creating this unique opportunity to consolidate these critical services and extend our thanks to Governor Sisolak and our elected leaders in Reno, Sparks and Washoe County for making this opportunity possible. We remain committed to working with our local government partners and other affected entities to facilitate the development of the *Nevada Cares Campus* and consolidation of the regional homeless services and welcome discussions to identify opportunities for the ROW to further contribute to these efforts.
