Sparks City Council Concurrent Meeting with the City of Reno, and Washoe County Board of Commissioners 1:00 P.M., Wednesday, January 20, 2021 This meeting was held virtually due to the COVID-19 pandemic – Hosted by the City of Sparks via ZOOM

1. Call to Order

The concurrent meeting was called to order by City of Sparks Mayor Ed Lawson at 1:00 p.m.

3. Pledge of Allegiance

4. Public Comment

Andrew Diss, Vice-President for Government Affairs with Meruelo Gaming called in public comment on behalf of Grand Sierra Resort requesting consideration of a clear appeals process from the Washoe County Health District that allows the appellant to be heard by a separate body than the one that originated the citation, and for fines to be issued to repeat offenders and not necessarily first-time offenses. He also expressed interest in working collaboratively with the Health District as a community vaccination site.

AnneMarie Grant called in public comment regarding the death of her brother, Thomas Purdy, and others who lost their lives at the hands of local law enforcement. She urged empathy during encounters with subjects who may be mentally unstable and seeking assistance from law enforcement.

City Clerk Lisa Hunderman read into record emails received. Cameron Harris emailed comment regarding the impacts of lack of enforcement of illegal parking and vehicle abandonments within City of Reno and regional limits. Dr. John Novak, DMD, District Board of Health Chair, emailed comment regarding established processes for people



aggrieved by decisions made by the Health District or who are seeking waivers from Health District requirements.

7. **Presentations**

7.1 Presentation and discussion regarding the establishment, structure, and membership of Washoe County Health District and District Board of Health. (FOR POSSIBLE ACTION)

A presentation from Sparks Assistant City Manager Alyson McCormick providing an overview of the establishment, structure, and membership of Washoe County Health District (WCHD) and its governing body, the District Board of Health.

Washoe County sought clarification on the membership makeup prior to 1993 and requested a timeline of when and how assignments were made; Mrs, McCormick

explained the 1986 amendment included a limitation for the City of Sparks stating only one appointee could be an elected official. That limitation was amended again in 1993 and applied to all three jurisdictions. Additionally, Mrs. McCormick confirmed she did not have a timeline of board assignments for the Board of Health, but assignments were made by the Nevada Legislature and its various administrative agencies.

8. General Business

8.1 Consideration, discussion, and possible direction to staff to negotiate a proposed amendment of the interlocal agreement concerning the Washoe County Health District. (FOR POSSIBLE ACTION)

A presentation from Sparks Assistant City Manager Alyson McCormick providing an overview of amendment options available pertaining to an interlocal agreement with Washoe County Health District. Council expressed interest in options that might increase the influence of elected officials at the November 18, 2020 concurrent meeting.

Mrs. McCormick explained there are four options to consider.

The first option, "Packing the Board", is not considered a viable option since adding more elected members to the Board would violate Nevada law.

The second option, creating an appellate body, is another consideration which Mrs. McCormick explained is not likely to be a viable option -- while the Board may exercise appellate powers or establish appellate bodies in specific subject matter areas, those powers are created by specific Nevada statutes or regulations. Therefore, the Board likely does not have authority to hear generalized appeals or create a general appellate body.

Mrs. McCormick went on to explain the third option, terminating the interlocal agreement and establishing a new health district, was also not advised (particularly during the global COVID-19 pandemic) because only a health district is authorized to perform certain functions. Further, the State Board of Health must approve the creation of a new health district, meaning it would likely be several months before the parties could establish a new health district.

The final option, amending the interlocal agreement, was the most feasible method presented for restructuring WCHD and the Board, per Mrs. McCormick. She also explained the agreement itself describes how it may be amended: "This agreement may be amended by mutual consent of the parties hereto not later than 90 days before its annual renewal date." Section 7(D). The renewal date is December 31 of each year, so the agreement may be amended before October 2 of each year. *See* Section 7(B). The governing bodies could direct their respective staffs to negotiate a proposed amendment to address any concerns the governing bodies may have. The governing bodies could then approve the proposed amended agreement.

Continued discussion included: Potential impacts on current franchise agreements; whether changes during a pandemic is really the best option for the region; ways to ensure Board direction comes from the Board itself and is not just reported; considerations and clarifications of the current appeals process; considerations of a Board name change to something more reflective of a cooperative effort that is autonomous from Washoe County; roles of elected officials as Board Chair and/or Vice Chair to increase influence; ways to make the appeals process simpler and more cohesive for constituents; the possibility of establishing industry liaisons to relay input to the Board; the need to ensure evidence-based decisions remain at the forefront over partisanship in the Board's decision-making processes; ways to better communicate the Health District's roles and limitations to the public; and the importance of including the Board in discussions.

Sparks Mayor Lawson thanked everyone for their dedication to collaboration and cohesiveness.

Barry Duplantis, REMSA Chief Financial Officer, called in public comment noting REMSA is proud to service the region. He reminded that REMSA services and their franchise agreement with the jurisdictions are directly impacted by any decisions made regarding the Board of Health.
