## MEMORANDUM OF UNDERSTANDING

May 27, 2014

This agreement is between the City of Sparks, Nevada, a municipal corporation ("City"), and the Operating Engineers Local Union No. 3 Non-Supervisory("OE3").

### 1. Recitals

- a. The City and OE3 Non-Supervisory entered into a multi-year collective bargaining agreement for the period beginning July 1, 2012 through June 30, 2015, which agreement was approved by the Sparks City Council on July 8, 2013 (the "Agreement").
- b. The City has a need to add six job families in the Maintenance Worker series and eliminate the generic title of Maintenance Worker I/II/III in the Operating Engineers Local Union No. 3 Non-Supervisory Contract.

The newly created job family classifications are: Parks Maintenance Worker, Streets Maintenance Worker, Traffic Maintenance Worker, Utilities Maintenance Worker, Facilities Maintenance Worker, and Community Appearance Maintenance Worker. The titles to be eliminated are: Maintenance Worker I/II/III in the Operating Engineers Local Union No. 3 Non-Supervisory Contract.

There are no changes in the number of employees authorized in these positions.

The parties met and have reached an interpretive understanding that required no change in language in the current Agreement, but required changes to "Appendix A - Job Classifications and Salary Wage Ranges" as follows:
