AN ORDINANCE AMENDING TITLE 15 OF THE SPARKS MUNICIPAL CODE, CONSTRUCTION, **BUILDINGS AND CHAPTER 15.01** BUILDING TRANSITION, CHAPTER 15.05 ADMINISTRATIVE CODE, BY ADOPTING THE 2018 EDITION OF THE INTERNATIONAL BUILDING CODE, INTERNATIONAL RESIDENTIAL CODE, INTERNATIONAL MECHANICAL CODE, UNIFORM MECHANICAL CODE, UNIFORM PLUMBING CODE, INTERNATIONAL FUEL GAS CODE, INTERNATIONAL ENERGY CONSERVATION CODE, INTERNATIONAL EXISTING BUILDING CODE, INTERNATIONAL WILDLAND-URBAN INTERFACE CODE, INTERNATIONAL SWIMMING POOL AND SPA CODE, 2017 EDITION NATIONAL ELECTRICAL CODE, 2018 NORTHERN NEVADA AMENDMENTS; AND OTHER MATTERS PROPERLY RELATED THERETO; AND PROVIDING OTHER MATTERS PROPERLY RELATED THERETO.

### THE CITY COUNCIL OF THE CITY OF SPARKS DOES ORDAIN:

**SECTION 1.** Section 15.01.0005: "Building code transition" is hereby amended as follows:

## Section 15.01.0005 - Building code transition.

Chapters 15.06, 15.07, 15.08, 15.09 and 15.10 are repealed in their entirety, effective September 1, 2013. When adopted by Sparks City Council an applicant for a building permit who submits his or her completed building permit application to the City of Sparks prior to September 1, 2013, may comply with any of the City's applicable building and construction new and previous code provisions.

When adopted by Sparks City Council an applicant for a building permit who submits his or her completed building permit application to the City of Sparks prior to July 1, 2019, may comply with any of the City's applicable building and construction new and previous code provisions.

**SECTION 2.** Section 15.05.100: "Adoption" is hereby amended as follows:

- **SECTION 3.** Section 15.05.104.1.4: "Baby changing table in a permanent building or facility used by the public" is hereby repealed in its entirety:
- **SECTION 4.** All ordinances or parts of ordinances in conflict herewith are hereby repealed.
- **SECTION 5.** The City Clerk is instructed and authorized to publish the title to this ordinance as provided by law.
- **SECTION 6.** This ordinance shall become effective upon passage, approval and publication.
- **SECTION 7.** The provisions of this ordinance shall be liberally construed to effectively carry out its purposes in the interest of the public health, safety, welfare and convenience.
- **SECTION 8.** If any subsection, phrase, sentence or portion of this ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions.
