An agenda item from City Clerk Teresa Gardner to canvass the votes of the 2016 Primary Election for the City of Sparks held on Tuesday, June 14, 2016 and declare the results within the 10 days as required by the Sparks City Charter Section 5.100 (2).

Ward 1 primary voting included Donald Abbott who received 25.25% of the vote, Adam Khan received 19.92% and Denise Lopez received 54.82%. Ms. Lopez and Mr. Abbott will move on to the general election.

Ward 3 and Ward 5 were not on the primary ballot as there are only 2 candidates for each ward (incumbent Ron Smith and John Rhoads for Ward 3; Kristopher Dahir and John Walter for Ward 5) and they will run in the general election.

City Attorney was not on the primary ballot as incumbent Chet Adams was the only candidate; Mr. Adams will be declared elected.

A motion was made by Council Member Smith, seconded by Council Member Lawson, to declare the results of the 2016 primary election as submitted. Council Members Ratti, Lawson, Smith, YES. Council Members Bybee, Schmitt, ABSENT. Passed unanimously with those present.
