Trap, Neuter, Return, Manage

Washoe County T,N,R,M

- Trap, Neuter, Return, Manage Programs begin in earnest in
 Washoe County in 1999 over 1,800 feral cats euthanized every year
- □ Over 30,000 feral cats have been spay/neutered
- 2012 citing TNR directly, the coalition of animal organizations and WCRAS receive the 2012 Maddie's Fund Community Lifesaving Award
- □ TNR fully funded by NHS and Community Cats no public funds



Washoe County Lifesaving

Decreased animals losing their lives in Washoe County shelters

2007: 52% decrease

2,700 fewer dogs & cats lost their lives in 2007 than 2006.

2008: 10% decrease

2009: 27% decrease

2010: 12% decrease


2011: no change

2012: 16% decrease





Traditional Management



- Community Cats/Free Roaming (FRC)
 Cats are unsocialized animals. They are not candidates for adoption
- Community Cats/FRC produce the majority of kittens entering the sheltering system
- Trap and Kill has universally failed.Ineffectual use of taxpayer dollars

Trap and Kill




- Totally, universally and without exception ineffectual
- Does not curtail population growth - can lead to increases in population. 20% growth annually
- Enormously expensive at the taxpayers expense
- Unacceptable to the public up to 27% of the public feed FRC
- □ SIMPLY DOES NOT WORK

Data and experience have led to a shift in Animal Control

Trap, Neuter, Return, Manage



- Humanely trapped
- Evaluated by a veterinarian
- Spay/Neutered
- Vaccinated
- Ear-Tipped
- Returned to their original habitat and managed
- Monitoring, GIS Tracking

Benefits of TNRM

- Reduces WCRAS intake (and eliminates unnecessary euthanasia)
- □ Cheaper, paid for privately rather than by taxpayers
- Protects public health, animal health

- Decreases nuisance complaints
- □ Stabilizes and then reduces FRC populations
 - □ UF 11 year study. Cats decreased by 66%, no new kittens born after the first 4 years
 - $\hfill\square$ Rome, study found colonies decreased by 16%-32% over 10 years.
- □ Managing to extinction
 □
- Vacuum effect
- Reduces roaming, yowling, fighting, spraying, mating behaviors
- Only effective, efficacy-substantiated method of FRC reduction
- Tracking of owned, unowned, FRC, and populations hot spots.


TNR Successes Jacksonville, Florida: Feral Freedom



Jacksonville reported:

- **→** Net savings: 2007–2010
 - \$160,000
 - 13,000 lives
- → Decrease in feline nuisance complaints
- ★31% decrease in feline shelter admissions
 - FY06-07: 13,455
 - FY09–10: 10,302

Jacksonville: Feral Freedom



Salt Lake City: Feral Fix

- ◆Feral Fix program (launched in 2008) reported:
 - 2008–2010: SLC improved its save rate by 40.4%
 Result: Overall cost savings of more than \$65,000
 - 2008–2010: Utah save rate only improved 4.7%
- ★In 2010, SLC realized a 21.8% <u>decrease</u> in shelter cat intake from 2009
- ◆No increase in feline nuisance complaints

Other Examples (as Reported by Some Organizations)

- Maricopa County, Arizona: cost per cat
 - \$61 to trap, hold and euthanize
 - \$23 to TNR
- ◆Indianapolis, Indiana: cost per cat
 - \$130 to trap, hold and euthanize (national average)
 - \$20 to TNR (IndyFeral)





Utah Community Cat Act §11-46-303



- ★Gives Utah cities the freedom to release cats immediately for TNR
- ◆Community cats are eligible for release prior to the 5-day hold period

Financial Reality



- The cost of national wide eradication (impossible) and estimated at 16 billion dollars
- □ The cost of national TNR under 2 billion dollars
- National average for housing and euthanizing one cat \$250
- Estimates place WC's FRC population anywhere from 25,000 to over 90,000

Cats ARE NOT the primary threat to birds or wildlife

- □ "By far the largest threat to birds is loss and/or degradation of habitat"*
 - Humane Development
 - Agriculture
- Chemical Toxins
- □ Direct Human Interaction
 - Hunting
 - Trapping

NHS provides deterrents


- □ NHS provides non-lethal, proactive strategies for deterrent
- □ Allows for citizens to deter cats from unwanted areas
- □ Free, effective, without TNRM there are no resources

Human Interactions



- Unsocialized cats avoid people, like most animals that exist in nature. They are not a risk
- Vaccinated thus public health is protected by TNR whereas it is not in Trap and Kill.
- Liability results from negligence
- Population is reduced. Lack of action could be considered negligence
- □ TRNM

Good Sense = Good Policy




- Humane treatment of animals is a public concern. Harris Interactive poll found 80% of Americans believe TNRM is more humane than Trap and Kill
- □ TNR is the only effective method of population control and population reduction
- □ Using population estimators based upon the number of households in WC (185,305) and the average cost to trap and kill (\$250) it would cost WC taxpayers \$23,163,125
- □ This would require one big roundup, cats don't stop reproducing. 1 cat, 4-6 kittens per litter, 2 litters per year. 1 cat = 10 kittens per year.
- \square 90,000 cats x 10 per year = catastrophe

Washoe County; A National Model



- □ 2012 safest place to be a dog or cat
- Combined efforts of NHS, Community
 Cats, FRONN, has yielded over 30,000
 FRC spay and neutered.
- Prevented hundreds of thousands of FRC
- Invested \$1,050,000 in direct surgical costs (\$35/surgery) in FRC alteration
- NHS and Community Cats will invest over \$392,000 in FRC and Cat Management (cat specific funding)
- □ WC is experiencing a steady
 DECREASE in cat intake 50% in kittens since 2012

Sparks Investments



- □ NHS invest well over \$1,000,000 every year in Sparks alone.
- NHS invested \$212,000 in s/n
 surgeries in 89431 over the past year
- Washoe County has the highest adoption per capita rate in the nation
- NNHS and Reno/Sparks appear on numerous top ten lists.
- 67% of households contain a pet, this is a quality of life issue

Land Use




- Feral Cat housing is not a risk
- Colony Caretakers do have responsibilities
- NHS trains caretakers how to feed appropriately
- WCRAS will pick up deceased animals
- Free roaming cats are not illegal
 in WC there are nuisance and
 trespassing ordinances in WC
