Should violations occur, the first re-inspection will not generate a fee. Subsequent inspections will be charged at \$65 per hour (approximate hourly cost with roll ups for a Fire Inspector II) with a minimum of 1 hour. Inspections are conducted in accordance with the Sparks Fire Prevention Bureau Occupancy Fire Inspection Frequency Schedule, i.e., Quarterly, Annually, Biennially, or Triennially.</i>

Self-Inspection Fee	0	\$25.00	<i>Optional self-inspection form with a \$25 administrative fee issued annually to non-permitted and non-high risk occupancies. Customer may request a fire inspector in lieu of self-inspection which will incur a \$65/hr. inspection fee. Non-compliance with self-inspection will result in a physical inspection with \$65/hr. fee. Fire Prevention Inspectors will perform periodic spot checks. Any additional re-inspection due to non-compliance will be \$65/hr.</i>

IFC Section 105.1.1 Permits required. Any property owner or authorized agent who intends to conduct an operation or business, or install or modify systems and equipment which is regulated by this code, or to cause any such work to be done, shall first make application to the fire code official and obtain the required permit.

- **Operational permit.** An operational permit allows the applicant to conduct an operation or a business for which a permit is required by Section 105.6 for either a prescribed period or until renewed or revoked.
