## REGULAR CITY COUNCIL MEETING MINUTES 2:00 P.M., Monday, April 22, 2019

City Council Chambers, Legislative Building, 745 Fourth Street, Sparks, Nevada

#### 1. Call to Order

The regular meeting of the Sparks City Council was called to order by Mayor Ron Smith at 2:00 p.m.

#### 2. Roll Call

Mayor Ron Smith, Council Members Donald Abbott, Ed Lawson, Paul Anderson, Charlene Bybee, Kristopher Dahir, City Manager Neil Krutz, City Attorney Chet Adams, and Acting City Clerk Lisa Hunderman, PRESENT.

#### 3. Opening Ceremonies

#### 3.1 Invocation Speaker

The invocation was provided by Council Member Kristopher Dahir.

#### 3.2 Pledge of Allegiance

The Pledge of Allegiance was led by Acting City Clerk Lisa Hunderman.

#### 4. Public Comment

Harvey Whittemore with Phoenix D'Andrea Acquisition LLC commented cleanup and restoration attempts continue for the clubhouse and property in efforts to comply with and meet code enforcement requirements. Mr. Whittemore also noted continued damage to the property by vandals makes this increasingly difficult. Mr. Whittemore commented an option will be given to D'Andrea homeowners to acquire the land necessary to build the golf course to 18 holes, however Phoenix will continue to restore and maintain a 9-course track and will pursue other commercial projects for the area. Mr. Whittemore stated he looks forward to continuing to work with City staff on the D'Andrea project to discuss how to bring effluent water, power, etc., to the property.

Sparks residents Kim Tracy, Gayle Miller, Wesley Griffin and George Lee each commented on a desire for Council to engage in a memorandum of understanding (MOU) with Washoe County and Washoe County School District. The residents would like the MOU to state any property at Wildcreek Golf Course not dedicated for use for the new school be allocated for continued use as a golf course or green space. Ms. Tracy additionally commented she would like Traffic Works, the company that provided a traffic study of the area, be vetted more closely to ensure a proper and complete study.

Mr. Lee, resident at 3506 Brassie Dr., provided comment he feels certain areas of planning for roadway construction on Sullivan Lane need to be looked at more closely, especially widening of the street between planned roundabouts, roadway lighting, and roadway water protection measures.

Council Member Lawson asked if a memorandum can be looked into, Mr. Krutz stated they would research.

#### 7.1 Proclamation: "50th Anniversary of Municipal Clerk's Week"

#### 7.2 Proclamation: "ALS Awareness Month"

Council proclaimed May 2019 as ALS Awareness Month. #### 7.8 Presentation: Mayor's Challenge

Presented by Suicide and Homeless Prevention Program Manager Kim Donohue, the Mayor's Challenge is meant to strengthen the capacity our interagency military and civilian team leaders to prevent and reduce suicide among Service Members, Veterans, and Families. With the Nevada Department of Veteran Services, the Truckee Meadows Team consists of members from the City of Sparks, City of Reno, Washoe County, and the Reno-Sparks Indian Colony. Ms. Donahue thanked Mayor Smith for being the first to accept this challenge and for the contributions of Council Members Dahir and Anderson as well as Mr. Walt Rosenberg who are among the team's representatives. Ms. Donahue reminded the fight to prevent and reduce suicide must be an on-going interagency and community effort. She also encouraged continued education on warning signs and how to support a person in need.

#### 7.9 Presentation: NDOT Proposed Safety Projects

Presented by Nevada Department of Transportation Traffic Safety Engineer Lori Campbell, the NDOT McCarran Blvd. Safety Projects include a roundabout at Baring, new right turn slip lanes @ Greg St. & Glendale Ave. intersections, and pedestrian fencing in the existing raised median. As well as, a 10-foot shared use path, mid-block pedestrian crossing, ADA ramps, and buffered bike lanes. Council asked if sound walls will fall into the scope of this project to promote residential safety, how much speed would be reduced by the roundabout at Baring Blvd and McCarran Blvd., and if there are future public meetings regarding this project. Ms. Campbell confirmed at this time sound walls are not part of the project due to jurisdiction and maintenance concerns, and the roundabout should reduce speed to about 25 mph. She also confirmed public meetings are held when the study is conducted, and again before final plans are approved and construction begins later in the summer.

#### 7.10 Presentation: Reno-Tahoe Airport Authority Annual Update

Presented by Reno-Tahoe Airport Authority President/CEO Marily Mora, the annual report for the Reno-Tahoe International Airport. The Reno-Tahoe International Airport is an economic engine for the region. It's the 63<sup>rd</sup> busiest

commercial airport in the U.S. and it served 4.2 million passengers in 2018. Future plans include adding more restaurants, apparel stores, and a new hotel slated to open 2020. Ms. Mora and Council thanked Sparks RTAA Board Trustees Art Sperber and Shaun Carey for their continued contributions to making the areas airports some of the best in the country.

9.7 FIRST READING of Bill No. 2755, an ordinance amending Section 20.03.046, Wireless communication tower or antenna, of the Sparks Municipal Code, revising one definition and adding a new definition within Section 20.08.002, making administrative changes, adding a new section establishing regulations for small wireless communication facilities located on private property, and providing other matters properly relating thereto.

The proposed changes to Section 20.03.046 are to clarify its provisions, respond to updated Federal Communications Commission requirements regarding macro towers, and add regulations for small wireless facilities installed on private property. The requested changes to Section 20.08.002 (Definitions) revise the existing definition for "Wireless communication tower or antenna" and add a new definition for "small wireless facilities."

9.8 FIRST READING of Bill No. 2756, an Ordinance amending Title 12 of the Sparks Municipal Code by adding Chapter 12.42.020 to address the construction, installation, and operation of small wireless facilities within the City right-of-way, and providing other matters properly related thereto.

The recommended addition of Chapter 12.42.020 to the Sparks Municipal Code will allow the City of Sparks to address the construction, installation, and operation of small wireless facilities located within City right-of-way. Adopting these rules by Ordinance will help the City address recent federal requirements ordered by the Federal Communications Commission.

9.9 FIRST READING of Bill No. 2757, an ordinance amending Chapter 5.77 of the Sparks Municipal Code to amend sidewalk cafes, revise one definition, add a new definition, add a section to establish regulations for pour stations during special events, and other matters properly relating thereto.

This agenda item proposes amendments to Chapter 5.77 - Sidewalk Cafes of the Sparks Municipal Code to revise and clarify regulations regarding permits for sidewalk cafes in the public right-of-way, including standards for the placement and demarcation of sidewalk cafes and the service of alcoholic beverages within sidewalk café areas.
