

AMENDMENT TO AND EXTENSION OF AGREEMENT FOR SERVICES BETWEEN WELLCARE SERVICES RENO, LLC AND WASHOE COUNTY, A POLITICAL SUBDIVISION OF THE STATE OF NEVADA.

WHEREAS the Parties to this Amendment and Extension are Parties to an Agreement for Services dated on or around March 30, 2020 ("Agreement"), which was extended in writing in May 2020 to June 27, 2020; and

WHEREAS the Parties seek to amend the Agreement pursuant to Section 6.15 which allows amendments in a writing executed by all Parties with the same formalities by which the Agreement was executed, to amend and extend the term of the Agreement to extend the Agreement beginning June 28, 2020 and ending October 31, 2020 (126 days), to reduce the number of beds to a total of 22 beds at a cost of \$100.00 per day per bed regardless of use, and an option for additional "overflow" beds as needed at a cost of \$100.00 per day for each overflow bed which is actually utilized, and to make other changes as described herein,

NOW THEREFORE in consideration of the foregoing premises and the following covenants, terms and conditions, the Parties do hereby agree as follows:

1. The Parties hereby amend and extend the Agreement as follows:

A. The term of the original Agreement shall be extended to October 31, 2020. Additional extensions may be granted in a writing signed and executed by all Parties with the same formalities by which the Agreement and this Amendment and Extension were executed.

B. Effective June 28, 2020, WELLCARE SERVICES, shall only be required to provide a total of 22 beds at a cost of \$100.00 per day per bed regardless of the number of beds actually used by the AGENCIES. WELLCARE SERVICES shall also provide additional "overflow" beds to the AGENCIES on an as needed basis at a cost of \$100.00 per day, per bed which is actually used by the AGENCIES.

C. The AGENCIES agree to pay a \$240.00 cleaning fee for each "overflow" bed actually used.

D. The maximum aggregate amount for all beds used and cleaning fees, and any other costs agreed to in this Agreement and Extension which are incurred by the AGENCIES for the period of time from June 28, 2020 to October 31, 2020, shall not exceed \$282,600.00. No expenditures beyond the \$282,600.00 are authorized or will be made unless AGENCIES first approve any such additional expenditures by approval of the appropriate AGENCIES' representatives pursuant to any declaration of emergency concerning COVID – 19 in effect at the time of any such approval.


E. The Agreement at Section 6.4 and at Attachment B at the second bullet of the second unnumbered section under "PAYMENT" shall each be amended to reflect that Aaron Kenneston has replaced Sam Hicks as the Incident Commander and is the person to whom notices should be sent for the Incident Management Team. F. the signatory for the City of Reno shall be Jason Soto, Acting City Manager.


