Call to Order (Time: 2:00 p.m.)

1. The regular meeting of the Sparks City Council was called to order by Mayor Geno Martini at 2:00 p.m.

Comments from the Public (Time: 2:03 p.m.)

Mr. Kevin Dick, representing Home Free NV/ Energy Fit Nevada, provided a follow-up from the proclamation of "EnergyFit Nevada Day" on October 22, 2012. One hundred twenty-eight energy assessments have been completed and 100 upgrades were identified. Forty-five upgrades have been completed with 22 of those in Northern Nevada, and 2 in Sparks. 




### Airline Industry is Transforming and Adapting to Restore Profitability



## EDAWN Assisted New Jobs 2007-2015 (5 Year Numbers Based On Company Estimate)






A motion was made by Council Member Ratti, seconded by Council Member Schmitt, to approve the consent items as submitted. Council Members Ratti, Lawson, Smith, Carrigan, Schmitt, YES. Passed unanimously.

# 5.1 Report of Claims and Bills approved for payment and appropriation transfers for the period December 27, 2012 through January 9, 2013. (FOR POSSIBLE ACTION)

An agenda item from Finance Manager Jeff Cronk recommending the City Council approve the report of claims and bills as presented in the staff report.

5.2 Consideration and possible approval of an Interlocal Agreement (A-3963) between the City of Sparks and the City of Reno for \$188,000 in Community Development Block Grant funding for improvements to the Community Assistance Center located on Record Street in Reno. (FOR POSSIBLE ACTION)

An agenda item from Housing Specialist George Graham recommending Council approve the Interlocal Agreement with the City of Reno which allows the City of Sparks to provide the City of Reno up to \$188,000 of CDBG funding for improvements, primarily to enhance security, at the Community Assistance Center (i.e., the homeless shelter facility) located on Record Street in Reno. The Sparks City Council previously earmarked funding for this project in the amended 2011/12 Action Plan, which has been approved by the U.S. Department of Housing and Urban Development. Funds have been approved in the FY2011/12 Annual Action Plan.

### 6. General Business

6.1 Consideration and possible approval of a \$1,000.00 donation to Partners in Parks and Recreation from Sierra Chemical Company. (FOR POSSIBLE ACTION) (Time: 2:50 p.m.)

An agenda item from Recreation Supervisor Andre Stigall recommending Council accept a donation to assist in supporting services and programs provided by the Parks and Recreation Department.

A motion was made by Council Member Ratti, seconded by Council Member Schmitt, to accept the \$1,000 donation to Partners in Parks and Recreation from Sierra Chemical Company. Council Members Ratti, Lawson, Smith, Carrigan, Schmitt, YES. Passed unanimously.

6.2 Consideration and possible acceptance of a grant (A#3964) from The Nell J. Redfield Foundation in the amount of \$50,000 for the Sparks Parks and Recreation Department to continue various programming in 2013. (FOR POSSIBLE ACTION) (Time: 2:51 p.m.)

An agenda item from Recreation Supervisor Shauna Nelson recommending Council accept a grant that will enable the Sparks Parks and Recreation Department to continue The Nell J. Redfield Free Neighborhood Playground Program and a portion of the Leisure Without Limits Program. Both programs provide for underserved populations within our community. Council Member Ratti said the fact that we repeatedly get this donation speaks of the quality of the program and staffs efforts. Mayor Martini thanked the Redfield Foundation.

A motion was made by Council Member Ratti, seconded by Council Member Lawson, to accept this grant (A#3964) as outlined from The Nell J. Redfield Foundation in the amount of \$50,000 for the continuation of The Nell J. Redfield Neighborhood Playground and Leisure Without Limits Programs as outlined by staff. Council Members Ratti, Lawson, Smith, Carrigan, Schmitt, YES. Passed unanimously.

6.3 FIRST READING and possible discussion of CA-7-12 Bill #2649 an ordinance by the City of Sparks amending Title 20, Chapter 20.07.030 of the Sparks Municipal Code (decisions subject to review and methods of appeal) to shorten the appeal period for Planning Commission and administrative actions and other matters properly related thereto. (Time: 2:54 p.m.)

City Clerk Teresa Gardner read the Bill by title; the 2<sup>nd</sup> reading was scheduled for the February 11, 2013 Council meeting.

6.4 PCN12036, City of Sparks, FIRST READING and possible discussion of Bill #2650 an ordinance rezoning 55 parcels totaling approximately 10.8 acres in size from the I/T (Industrial/Transitional Overlay) to I ((Industrial) generally located south of Interstate 80, east of South 21st Street, west of South Rock Boulevard, and north of Pittman Avenue (extended). (Time: 2:54 p.m.)

City Clerk Teresa Gardner read the Bill by title; the 2<sup>nd</sup> reading was scheduled for the February 11, 2013 Council meeting.

6.5 FIRST READING and possible discussion of CA-6-12 Bill #2651 an ordinance amending Title 20 of the Sparks Municipal Code to modify the expiration provisions for Special Use Permits (Chapter 20.13) and Site Plan Review (Chapter 20.31) and other matters properly relating thereto. (Time: 2:55 p.m.)

City Clerk Teresa Gardner read the Bill by title; the 2<sup>nd</sup> reading was scheduled for the February 11, 2013 Council meeting.

6.6 FIRST READING of Bill #2652 amending the Sparks Municipal Code relating to Business Licenses; Clarifying and Strengthening Numerous Provisions Regarding Business Licenses, including: Applications; Denials, Audits, Inspections, Delinquencies, Penalties, Expiration, Suspension, Revocation and Criminal Prosecution; Requiring certain Tax-Exempt Activities to obtain a license (at no cost); and providing other matters properly related thereto. (Time: 2:56 p.m.)

City Clerk Teresa Gardner read the Bill by title; the 2<sup>nd</sup> reading was scheduled for the February 11, 2013 Council meeting. City Attorney Chet Adams stated this Bill will inner delineate an amendment to read "City Manager or his designee" everywhere it says "City Manager" and "Finance Director" will be changed to "Financial Services Director".

## 6.7 Review, discussion and possible approval of a Sparks business visitation program (FOR POSSIBLE ACTION) (Time: 2:57 p.m.)

An agenda item from City Planner Armando Ornelas recommending Council direct staff to refine and initiate the proposed business visitation program. This agenda item outlines a proposed new program to have Sparks' Mayor, City Council and staff visit companies doing business in Sparks. The proposal is in response to the interest the City Council showed in conducting company visits during their November 2012 workshop discussion on economic development. The visits are intended to encourage the retention and expansion of companies doing business in Sparks by demonstrating the City's appreciation for these companies presence in Sparks, discussing their concerns and identifying issues on which the City (or other entities) could provide resolution or assistance. The estimated cost is \$3,000.

Mr. Ornelas reviewed the steps of the plan and Council offered suggestions. The plan is proposing a staff member accompany an elected official to visit companies already doing business in Sparks to help retain companies and assist in any expansion while expressing appreciation for them being here. In addition, staff would want to learn about any concerns and develop ways to address those concerns. Businesses could be identified by various methods, size, new, old, special request, etc. The program would be ready to implement in March and the goal would be to reach 75 businesses by the end of November 2013.

A motion was made by Council Member Lawson, seconded by Council Member Ratti, to approve the Sparks business visitation program as outlined by staff. Council Members Ratti, Lawson, Smith, Carrigan, Schmitt, YES. Passed unanimously.

6.8 Consideration and possible direction to City staff regarding the City's advance planning program, including possible amendments to Title 20 of the Sparks Municipal Code and the Sparks Master Plan. (FOR POSSIBLE ACTION) (Time 3:08 p.m.)

An agenda item from Senior Planner Jim Rundle recommending Council endorse the proposed advance planning work program. This agenda item summarizes the City Council's direction, recommendations in the consultant-prepared zoning code analysis and existing efforts. The result is a proposed advance planning work program for approximately the next 18-24 months. Staff is seeking City Council endorsement of, or alternative direction regarding, the proposed work program. There is no impact to the general fund.

Mr. Rundle discussed current and upcoming planning projects and requested input from Council members. Table 1 addressed items currently being worked on by staff such as reduction of appeal periods for special use permits and site plan reviews; rezoning of Conductor Heights to industrial, extension of expiration date of a site plan review or special use permit from one year to two years and TOD amendments.

Table 2 included items needing support of an outside planning consultant such as major deviations, parking as a permitted use in the industrial area, sign code amendments, master plan updates, RV length of stay in RV park, urban agriculture, new master table of permitted uses, new definitions for permitted uses, reduce the number of uses requiring a special use permit, redistribution of uses across zoning districts and administrative manual for "new" zoning code.

Table 3 are concepts from the zoning analysis that Council has not directed staff to work on and included an auto oriented use policy along Prater and Victorian, an alternative compliance tool, industrial design standards. Review parking standards and amend landscape standards.

Council Member Ratti said the description was accurate, however, she would like to add an item to address the number of liquor stores in the urban core.

A motion was made by Council Member Smith, seconded by Council Member Ratti, to endorse the work program as outlined by staff. Council Members Ratti, Lawson, Smith, Carrigan, Schmitt, YES. Passed unanimously.
