Engineer's Estimate - \$792,380 so seeking approval of a not-to-exceed amount of \$800,000.







Exhibit 1. Proposed Sections for Victorian Square Infrastructure Improvement Project Map

## **Capacity to Fund Section 4 Project**

Lodging Tax fund had an unaudited ending fund balance at the end of fiscal year 2020 (June 30, 2020) of \$4,838,018.

The City's current commitments for use of Lodging Tax proceeds total approximately \$944,000.

Lodging Tax fund has capacity for allocation of \$800,000 for Section 4.

## Significance of this Agenda Item

City Council acceptance of Resolution No. 5 enables City to use Lodging Tax proceeds for Section 4 project.

Staff will seek award of a construction contract later this year.

#### **Staff Recommendation & Alternative**
