Pursuant to authority conferred by Section 3.11 of the Sparks City Charter, Chapter 180, 1949 Statutes of Nevada, and after public hearing duly noticed and had, and no objections to proposed action having been made, IT IS HEREBY ORDERED AND DECLARED that the block long portion of "G" Street running westward from Stanford Way, laying just south of Prater Way, in the Lincoln Park Addition to the City of Sparks, as of record in the office of the Washoe County Recorder, is hereby abandoned and vacated, and the same is hereby made a part of the property of adjoining property owners abutting on said portion of said street, as indicated in the amended plat on file in the Sparks City Clerk's office.

IT IS FURTHER RESOLVED that a copy of the plat herein involved, duly certified by the City Engineer and a copy of this Resolution duly certified by the City Clerk shall be at once filed in the office of the Washoe County Recorder and upon such filing the action herein taken shall be deemed complete.


Gentlemen:
