6.2 Consideration and possible approval of Amendment No. 1 to the Parking Agreement (AC-SRA-315) between the Sparks Redevelopment Agency, the City of Sparks and Syufy Enterprises that extends terms of the agreement and grants Syufy the right to construct an entrance in the western exterior wall of the parking structure. (FOR POSSIBLE ACTION) (Time: 4:18 p.m.)

An agenda item from Assistant Community Services Director Armando Ornelas recommending the Redevelopment Agency approve the amendment. The City Council and Redevelopment Agency approved the Parking Agreement on October 10, 2016. Per its terms, the city agreed to continue providing free parking for the movie theater, owned by Syufy Enterprises, in the adjacent, city-owned Victorian Square parking structure if the theater is renovated and reopens prior to December 31, 2017. Syufy requested a nine-month extension from December 31, 2017 to September 30, 2018 to provide Syufy and Galaxy Theatres, Syufy's new tenant for the theater, additional time to fully renovate the property. In addition, Syufy and Galaxy have requested approval from the city to install a direct entrance between the theater and the parking structure to facilitate access for their patrons.

A motion was made by Agency Member Dahir, seconded by Agency Member Abbott, to approve Amendment No. 1 to the Parking Agreement between the Sparks Redevelopment Agency, the City of Sparks and Syufy Enterprises. Agency Members Abbott, Lawson, Smith, Bybee, Dahir, YES. Agency Member Martini, ABSENT. Passed unanimously with those present.
