6.2 Consideration and possible approval of Resolution No. R-SRA131 authorizing the issuance of Redevelopment Agency of the City of Sparks, Nevada, Tax Increment Revenue Refunding Bonds (Redevelopment Area No. 2), Series 2016, and the execution and delivery of documents relating thereto. (FOR POSSIBLE ACTION) (Time: 4:00 p.m.)

An agenda item from Chief Financial Officer Jeff Cronk recommending the Agency approve the resolution authorizing the issuance of Tax Increment Revenue Refunding Bonds, Series 2016. The Redevelopment Agency has an opportunity to refinance the Tax Increment Revenue Bonds that were originally issued in 2008 and take advantage of lower interest rates. Preliminary estimates indicate that the proposed refunding bonds will enable the Agency to realize a net present value savings of approximately \$1.6 million over the remaining life of the bonds. By approving the attached Bond Resolution, the Agency Board also authorizes the execution of the 2016 Bonds Indenture, the Escrow Agreement, and the Waiver & Consent Agreement, all of which are attached. Execution of the documents is expected to occur in mid-October. Debt service will see a savings of approximately \$1.6 million, net present value, over the remaining life of the outstanding debt.

A motion was made by Agency Member Martini, seconded by Agency Member Lawson, to approve Resolution No. R-SRA131, a Resolution authorizing the issuance of the Redevelopment Agency of the City of Sparks, Nevada, Tax Increment Revenue Refunding Bonds (Redevelopment Area No. 2), Series 2016; and the execution and delivery of documents relating thereto. Agency Members Ratti, Lawson, Smith, Martini, Bybee, Schmitt, YES. Passed unanimously.
