I would like to thank you for your continued participation in, and support of, the League. We derive our strength as an organization from our members and appreciate the contributions of the City of Sparks. As you know, we have recently completed the 2017 Legislative session. I believe that we had a successful session. We were able to get Assembly Bill 8 passed and signed by the Governor. This bill authorizes an incorporated city to place delinquent water and storm drainage bills on the property tax roll for collection. Previously cities could only place delinquent sewer bills on the tax roll. We were also actively involved in marijuana legislation and maintained the rights of cities to license and regulate marijuana businesses. We look forward to continuing to work on municipal priorities in future sessions.

We are a state sponsor of the U.S. Communities national government purchasing program. Our members can take advantage of the program's nationwide purchasing power and realize reduced costs by purchasing necessary products and services through U.S. Communities. We have also become a sponsor of Utility Services Partners. This company offers insurance for homeowners for leaks on the property owner's side of the water meters and sewer mains. As you know, many property owners are unaware that they are responsible for those leaks. We are also a sponsor of BoardDocs which is an electronic document service for meeting agenda packets.
