### Amendment to Agreement between the City of Sparks and Saint Mary's dated June 23, 2008.

This Amendment to the Agreement between the City of Sparks and Saint Mary's Regional Health Center is premised upon the following recitals:

### RECITALS

WHEREAS, the parties' June 23, 2008, Agreement established Saint Mary's as a sponsor for certain park areas within the City of Sparks and a sponsor for certain City events for a fee, and the City of Sparks in return allowed Saint Mary's to place appropriate signage in designated areas, and

WHEREAS, the parties wish to continue that sponsorship relationship, and

WHEREAS, the parties desire that this Amendment will amend only those provisions of the June 23, 2008, Agreement specifically designated herein,

NOW, THEREFOR, BASED UPON THE FOREGOING RECITALS WHICH ARE INCORPORATED HEREIN AND IN CONSIDERATION OF THE MUTUAL PROMISES AND BENEFITS TO BE EXCHANGED AND PROVIDED, THE PARTIES AGREE AS FOLLOWS:

Paragraph 6 of the June 23, 2008, Agreement is hereby replaced with the following language:

### 6(A)(1) SPARKS HOMETOWNE CHRISTMAS PARADE PRESENTED BY INTUIT

Saint Mary's shall be acknowledged and treated as a 'Major Sponsor' at the Sparks Hometowne Christmas Parade in the years 2012 through and including 2015 with all the rights, privileges and responsibilities attached thereto and as defined by the City of Sparks.

### 6(A)(2) SCHEEL'S THANKSGIVING TURKEY TROT

Saint Mary's shall be acknowledged and treated as a "Major Sponsor" at the Scheel's Turkey Trot for the years 2012 through and including 2015 with all the rights, privileges and responsibilities attached thereto and as defined by the City of Sparks.

### 6(B)(1) ALF SORENSEN SPONSORSHIP

The parties agree that Saint Mary's will continue their sponsorship of Alf Sorensen Recreation Center in the pool area and the gym area as set forth and incorporated herein in **Exhibit A.** Saint Mary's agrees to a onetime payment in the amount of FIFTEEN THOUSAND DOLLARS (\$15,000.00), 50% to be paid by November 30, 2012, and the

remaining 50% paid by January 31, 2013, which covers a two year period of sponsorship for the Alf Sorensen Recreation Center for the period of November 1, 2012 through October 31, 2014.

### 6(B)(2) SHADOW MOUNTAIN SPONSORSHIP


The parties agree that Saint Mary's will continue their sponsorship at Shadow Mountain baseball fields for two years with a payment in the amount of SEVEN THOUSAND FIVE HUNDRED DOLLARS (\$7,500.00) and the 12 outfield panels currently in place at the Shadow Mountain will remain as is as shown in **Exhibit B.** The payment of the sponsorship amount will be made in two payments, 50% by November 30, 2012 and the remaining 50% paid by January 31, 2013, and will continue the sponsorship for two years until October 31, 2014.

The parties agree that Saint Mary's will no longer provide sponsorship at the Sparks Marina and Saint Mary's shall not be a "Major Sponsor" at Farmer's Market.

All other remaining provisions of the Agreement shall remain in force and effect and shall not be altered by this Amendment.


