RESOLUTION AND ORDER DEEDING LAND

WHEREAS Tract Map No. 117 was filed in Official Records of Washoe County, Nevada on April 25, 1904 as Town of Sparks; said Tract Map dedicated land and or right of way for public thoroughfare; and

WHEREAS Sparks entered into an Interlocal Agreement pursuant to NRS 277.180 with the State of Nevada acting by and through its Department of Transportation (also referred to as the "Department") to transfer that portion of said land and or right of way as described in Exhibit "A" and depicted in Exhibit "A1", as attached hereto and by reference made a part hereof, and said Interlocal Agreement was reviewed and approved by the Sparks City Council on April 11, 2011; and

WHEREAS NRS 277.053 provides that a governing body may transfer any real property owned by the city to the State if the property is to be used for public purpose; and

WHEREAS the conveyance of the above described property to the State will restrict the use of the real property for public purposes; and

WHEREAS it is in the best interest of the citizens of the City of Sparks that the described property be transferred to the State.

NOW THEREFORE IT IS ORDERED BY THE CITY COUNCIL OF THE CITY OF SPARKS, NEVADA:

- Section 1. That, subject to any and all existing easements whether of record or not, on the land described in Exhibit "A", and "A1" shall remain in full force and effect in accordance with their terms; and
- Section 2. That subject to the above provisions, the City of Sparks does hereby order and approve of the transfer and DEED by QUIT CLAIM all of its rights regarding the property described in Exhibit "A" and depicted in Exhibit "A1" attached hereto and made part of, to THE STATE OF NEVADA acting by and through the its Department of Transportation (as provided in NRS 277.053, 277.180 and 268.062(e)(2) and other provisions of Nevada law) in its "AS IS" condition; and
- Section 3. The officers of the City are hereby authorized and directed to take all action necessary to effectuate the provisions of this resolution and to accomplish its purposes, including the recording of this resolution and order in the official records of Washoe County, Nevada. The City Clerk is hereby authorized to execute any documents intended to accomplish the purposes of this order.
 - Section 4. If any provisions in this resolution and order is deemed

invalid or unconstitutional by any court of competent jurisdiction, such offending provision shall be deemed a separate, distinct and independent provision and such holding shall not affect the validity of the remaining provisions herein.


